

The 2011-12 school year was an eventful and exciting one at Baltimore School for the Arts, marking the first year under the leadership of Director Chris Ford. Contributions from the community, so crucial in enabling the BSA to thrive, were stronger than ever. On behalf of all of us, we are grateful for the incredible support for our students, for our programs, and for this model school that continues to be such an important educational and cultural institution in Baltimore and the surrounding community. Just a few of the highlights from the year:

- ▶ Ninety-four students (our biggest class ever) graduated in June with 100% heading off to some pretty impressive colleges including Princeton, Dartmouth, Brown and Columbia with over \$6.2 million dollars in scholarships and grants. Many also received recognition in national competitions including fourteen students in the prestigious National Foundation for Advancement in the Arts Young Arts Competition.
- ▶ Myrna Cardin, Senator Benjamin Cardin's spouse, invited ten of our students to perform at the annual *Spouses of the Senate Luncheon* at the US Botanic Garden. BSA senior music students performed as the guests entered and then eight senior singers were featured performing folk songs as arranged by Aaron Copland. The guest of honor was Mrs. Obama.



- ▶ The BSA Foundation, thanks to the generous support of donors and fans who support the school, awarded 26 grants totaling \$43,000 to juniors to attend summer programs at places including Joffrey Ballet; NY Conservatory; MICA in Tuscany; NYU, Tanglewood; NYU Shakespeare Program; and the Cleveland Institute of Art to name just a few.
- ▶ Senior theatre students took a trip to London in an exchange program with Showdown Theatre Arts where they rehearsed and performed "Working" based on the Studs Terkel book! Stage Production students travelled to Stratford, Canada to study their art there.
- ▶ In May, BSA presented the U.S. premiere of Marius Petipa's "Cavalry Halt" a 19th century piece, originally created for the Russian ballet by the renowned French choreographer Marius Petipa. It was beautifully restaged by BSA dance instructors Bat Udval and Evgenia Singur, who studied and performed with the Bolshoi. The work featured romance, comedy, folk dance and classical ballet in a charming story set in a small Austrian village.
- ▶ Sophomore theatre and stage productions students were cast and crew in "Fighting for Freedom" at Fort McHenry and the Maryland Historical Society, a joint production featuring a three-scene play researched by BSA students. The project was featured in the Baltimore Sun.
- ▶ Through outreach efforts, the BSA offered free arts programming to upwards of 4,000 children, including 700 kids in the second through eighth grades who received free arts instruction in TWIGS. TWIGS was recognized as one of Baltimore's best after school programs, and the BSA Foundation as one of the state's best organizations giving back to Maryland arts, by CBS Baltimore.

The Annual Fund

The Annual Fund is the centerpiece of the school's fundraising efforts each year, providing about a third of the funding for the school. In FY 2011-2012, the Baltimore City Public School System covered 68% of BSA's operating budget, paying faculty salaries, building maintenance, and security costs. The remaining 32% – the funding for all arts programming and classroom materials – was raised from private donations. This included financial support for the school's TWIGS program and other outreach efforts, as well as all costs associated with performances and exhibitions in the high school; scholarships for summer study and college bound seniors; master classes and cultural outings; test preparation and tutoring; and all of the equipment and supplies.

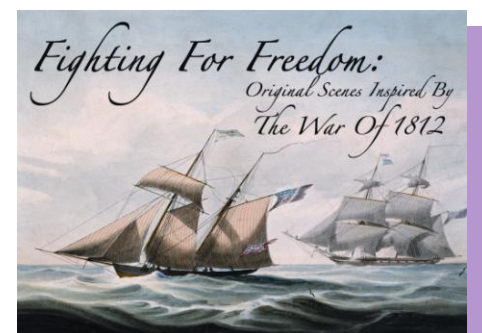
